General Information

GAI-Tronics Model 354-001 series NEMA 4X Industrial Telephones are designed for use in extreme weather conditions where temperature and moisture are a concern. They are also ideal for use in areas that require a direct water spray (hose-down) for cleaning purposes or where a non-corrosive material is required.

The 354-001 series Telephone is perfectly suited for areas considered too harsh for a standard telephone.

The 354-001 series Telephone operates in the same manner as a standard telephone – simply lift the handset, listen for a dial tone, and dial the desired telephone number. The telephone is completely line-powered.

Installation Guidelines

<u>ATTENTION</u> Installation should be performed by qualified personnel and only in accordance with the National Electrical Code or applicable local codes.

Safety Guidelines

When installing any GAI-Tronics telephone equipment, please adhere to the following guidelines to ensure the safety of all personnel:

- NEVER install telephone wiring during a lightning storm.
- Install a UL Listed lightning arrestor on any telephone installed where the telephone or telephone cable is at risk of being exposed to lightning strikes. The lightning arrestor must be installed as close as possible to maximize the protection. It must not be installed within the enclosure supplied with the telephone. Please consult our Service Center at 800-492-1212 for further information.
- Do not install telephone jacks in wet locations unless the jack is specifically designed for wet locations.
- Do not touch uninsulated telephone wires or terminals unless the telephone line has been disconnected at the network interface.

Installation

WARNING ! This product can contain hazardous voltages. Always remove power to this station and any associated equipment before beginning any installation.

CAUTION Do not install this equipment in areas other than those indicated on the approval listing in the "Specifications" section of this manual. Such installation may cause a safety hazard and consequent injury or property damage.

Install equipment without modification and according to all applicable local and national electrical codes. Consult the National Electrical Code (NFPA 70), Canadian Standards Association (CSA 22.1), and local codes for specific requirements regarding your installation. Class 2 circuit wiring must be performed in accordance with NEC 725.55.

Security Hardware

The Model 354-001 series Telephone is vandal-resistant, with the front panel attached to its enclosure with security screws. A GAI-Tronics Model 233-001 Security Screwdriver (sold separately) or Torx T-25 security head tip (included with the telephone) is recommended for installing the security screws.

Conduit Installation Details

GAI-Tronics recommends installing telephone cable in conduit to protect against damage and vandalism. Mounting and wiring of the Model 354-001 series Telephones must be in accordance with installation standard practices.

Entering the enclosure from the top is not recommended. Bottom (preferred) or side entry helps prevent condensation moisture from dripping onto the telephone electronics causing severe damage. If using conduit, an appropriate hub (Myers STG series recommended) or a UL Listed NEMA 4X rated connector appropriate for the installation should be used. If a top entry must be made, a drip path is strongly recommended. Seal all conduit entrances around the entry point and inside the conduit using a silicone-type sealant.

The Model 354-001 series Telephones are not supplied with openings for conduit or cable because of potential installation variations. Conduit entrances must be installed prior to mounting the enclosure to the wall surface.

- 1. Open the door and remove the front panel assembly (carefully set aside).
- 2. Drill (hole saw) or punch entry openings using the template provided with the telephone. There must be a minimum of 1 inch (26 mm) of material between entry holes.
- 3. Install hub or fitting.

Mounting the Enclosure




Figure 2. Mounting and Entry Locations

Mount the enclosure using the four 0.437-inch (11mm) diameter holes located on the mounting flanges with 3/8-inch (M8) hardware. For specific details, including mounting hole dimensions and spacing, refer to Figure 2.

Wiring and Testing

- 1. If mounting outdoors, install a lightning arrestor/suppressor (customer-supplied) on the telephone line.




Figure 3. Interior of the Front Panel




Figure 4. TB1 Terminal Block on Industrial Telephone PCBA

- 2. Connect the incoming subscriber line (red and green) or line suppressor to the Main PCBA terminal strip. See Figure 3 and Figure 4.
- 3. Install panel assembly in the enclosure and fasten security screws.
- 4. Check for proper telephone operation by calling to and from another telephone.

Ring Relay Kit

The Ring Relay Kit allows the telephone to activate a peripheral device, such as a beacon or sounder, when ring voltage is present. The kit includes a PCBA, mounting hardware, and USOC RJ11C Module connector cord (provided with the kit).

When installed, the Ring Relay PCBA is connected to the Industrial Telephone PCBA via the USOC RJ11C modular connector cord. This allows the telephone input wiring to be connected directly to the Ring Relay PCBA. The Ring Relay PCBA is installed on the back of the front panel. See Figure 3 for mounting and steps 1 through 3 in the "Ring Relay Wiring" section.

Installing the Ring Relay PCBA

- 1. Install the two standoffs (provided) onto the back of the panel as shown in Figure 3.
- 2. Align the Ring Relay PCBA with the two standoffs and secure using the two 6-32 screws provided.

Ring Relay Wiring




Figure 5. Ring Relay PCBA Wiring

- 1. Connect the incoming subscriber line to the TB1 terminal block. See Figure 5.




Figure 6. Device Interconnection

- 2. Connect the external sounder or beacon to TB2 for activation with an incoming telephone call. See Figure 5 and Figure 6.
- 3. Before reattaching the panel assembly, connect the USOC RJ11C modular connector cord (provided with the Ring Relay Kit) from the Industrial Telephone PCBA to the Ring Relay PCBA.

Operation

- 1. Lift the handset to place a call.
- 2. The handset receiver volume control, which is located on the stainless steel front panel, can be adjusted to the desired level by momentarily pressing the push button.

NOTE: Pressing the volume push button increases the volume in 3 dB increments. The volume starts at 0 dB and increases to a maximum of 18 dB. Pressing the push button a seventh time returns the volume to 0 dB.

- 3. Dial the desired number.
- 4. After completion of the call, place the handset on-hook.

Volume Control Jumper Setting

The handset receiver volume control is factory-set to default to its original setting (0 dB) when the telephone is hung up. To save the volume control setting, jumper **J4**, which is factory-set at positions **2** and **3**, must be moved to positions **1** and **2**, after the desired volume is reached.

User Instructions (USA)

This equipment has been tested and found to comply with the limits for a Class A digital device, pursuant to part 15 of the FCC Rules. These limits are designed to provide reasonable protection against harmful interference when the equipment is operated in a commercial environment. This equipment generates, uses, and can radiate radio frequency energy and, if not installed and used in accordance with the instruction manual, may cause harmful interference to radio communications. Operation of this equipment in a residential area is likely to cause harmful interference in which case the user will be required to correct the interference at his own expense.

This equipment complies with Part 68 of the FCC rules. Located on the equipment is a label that contains, among other information, the FCC registration number and ringer equivalence number (REN). If requested, this information must be provided to the telephone company. The REN is used to determine the quantity of devices which may be connected to the telephone line. Excessive REN's on the telephone line may result in the devices not ringing in response to an incoming call. In most, but not all areas, the sum of the REN's should not exceed five (5.0). To be certain of the number of devices that may be connected to the line, as determine by the total REN's contact the telephone company to determine the maximum REN for the calling area. This equipment cannot be used on the telephone company-provided coin service. Connection to Party Line Service is subject to State Tariffs. If this equipment causes harm to the telephone network, the telephone company will notify you in advance that temporary discontinuance of service may be required. If advance notice isn't practical, the telephone company will notify the customer as soon as possible. Also, you will be advised of your right to file a complaint with the FCC if you believe it is necessary. The telephone company may make changes in its facilities, equipment, operations, or procedures that could affect the operation of the equipment. If this happens, the telephone company will provide advance notice in order for you to make the necessary modifications in order to maintain uninterrupted service.

If the trouble is causing harm to the telephone network, the telephone company may request you to remove the equipment from the network until the problem is resolved. This equipment uses the following USOC jacks: RJ11CIt is recommended that the customer install an ac surge arrester in the ac outlet to which this device is connected. This is to avoid damaging the equipment caused by local lightening strikes and other electrical surges. This equipment is Hearing-Aid Compatible (HAC). The telephone Consumer Protection Act of 1991 makes it unlawful for any person to use a computer or other electronic device, including fax machines, to send any message unless such message clearly contains in a margin at the top or bottom of each transmitted page or on the first page of the transmission, the date and time it is sent and an identification of the business or other entity, or other individual sending the message and the telephone number of the sending machine or such business, other entity, or individual. User Instructions (Canada) CP-01, Issue 8, Part I: Section 14.1

NOTICE: The Industry Canada label identifies certified equipment. This certification means that the equipment meets certain telecommunications network protective, operational and safety requirements as prescribed in the appropriate Terminal Equipment Technical Requirements document (s). The Department does not guarantee the equipment will operate to the user's satisfaction. Before installing this equipment, users should ensure that it is permissible to be connected to the facilities of the local telecommunications company. The equipment must also be installed using an acceptable method of connection. The customer should be aware that compliance with the above conditions may not prevent degradation of service in some situations. Repairs to certified equipment should be coordinated by a representative designated by the supplier. Any repairs or alterations made by the user to this equipment, or equipment malfunctions, may give the telecommunications company cause to request the user to disconnect the equipment. The termination on an interface may consist of any combination of devices subject only to the requirement that the sum of the Ringer Equivalence Numbers of all the devices does not exceed 5.

Warranty

Equipment. GAI-Tronics warrants for a period of one (1) year from the date of shipment, that any GAI-Tronics equipment supplied hereunder shall be free of defects in material and workmanship, shall comply with the then-current product specifications and product literature, and if applicable, shall be fit for the purpose specified in the agreed-upon quotation or proposal document. If (a) Seller's goods prove to be defective in workmanship and/or material under normal and proper usage, or unfit for the purpose specified and agreed upon, and (b) Buyer's claim is made within the warranty period set forth above, Buyer may return such goods to GAI-Tronics' nearest depot repair facility, freight prepaid, at which time they will be repaired or replaced, at Seller's option, without charge to Buyer. Repair or replacement shall be Buyer's sole and exclusive remedy. The warranty period on any repaired or replacement equipment shall be the greater of the ninety (90) day repair warranty or one (1) year from the date the original equipment was shipped. In no event shall GAI-Tronics warranty obligations with respect to equipment exceed 100% of the total cost of the equipment supplied hereunder. Buyer may also be entitled to the manufacturer's warranty on any third-party goods supplied by GAI-Tronics hereunder. The applicability of any such third-party warranty will be determined by GAI-Tronics.

<u>Services.</u> Any services GAI-Tronics provides hereunder, whether directly or through subcontractors, shall be performed in accordance with the standard of care with which such services are normally provided in the industry. If the services fail to meet the applicable industry standard, GAI-Tronics will re-perform such services at no cost to buyer to correct said deficiency to Company's satisfaction provided any and all issues are identified prior to the demobilization of the Contractor's personnel from the work site. Re-performance of services shall be Buyer's sole and exclusive remedy, and in no event shall GAI-Tronics warranty obligations with respect to services exceed 100% of the total cost of the services provided hereunder.

<u>Warranty Periods.</u> Every claim by Buyer alleging a defect in the goods and/or services provided hereunder shall be deemed waived unless such claim is made in writing within the applicable warranty periods as set forth above. Provided, however, that if the defect complained of is latent and not discoverable within the above warranty periods, every claim arising on account of such latent defect shall be deemed waived unless it is made in writing within a reasonable time after such latent defect is or should have been discovered by Buyer.

<u>Limitations / Exclusions.</u> The warranties herein shall not apply to, and GAI-Tronics shall not be responsible for, any damage to the goods or failure of the services supplied hereunder, to the extent caused by Buyer's neglect, failure to follow operational and maintenance procedures provided with the equipment, or the use of technicians not specifically authorized by GAI-Tronics to maintain or service the equipment. THE WARRANTIES AND REMEDIES CONTAINED HEREIN ARE IN LIEU OF AND EXCLUDE ALL OTHER WARRANTIES AND REMEDIES, WHETHER EXPRESS OR IMPLIED BY OPERATION OF LAW OR OTHERWISE, INCLUDING ANY WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

Return Policy
