
The Model 314E can be used with any microphone similar in shape to the 631B or 635A.

INSTALLATION

The 314E slips over the end of the microphone easily by hand. A snug fit is all that need be checked.

IMPORTANT NOTICE:

To accomplish the greatest possible wind blast reduction, it is recommended that a Model 513 filter be used with the microphone and the Model 314E. The 513 is
